

TRIP REPORTS:

C.R.F. Lower Cave Restoration at Carlsbad Caverns August 30-31, 1997

Tom Kaler and I drove with Meliene Davis to Carlsbad in order to help the C.R.F. clean the flowstone leading in to Lower Cave and the area around the cave pearls in the Rookery. This was our alternative trip as economics kept us from going to Bustamante as we wanted.

Saturday morning we were assigned work groups. Tom and I worked in the Rookery with Lois Lyles and Kevin Justice. Meliene worked with Barb Barker and a group of other cavers on the flowstone. And, some C.R.F. members surveyed. I was surprised at how nice the new ladders are leading in to Lower Cave by far easier than the old ones. When Lois, Kevin, Tom and I reached our destination, Lois showed us her previous work and it was amazing. The silt she and Kevin have removed from around the pearls and in the pools dramatically changed the look of the Rookery. It is so much whiter and prettier as if making the Rookery prettier was actually possible.

Lois put Tom and me to work and we removed enough silt and debris to fill half of a five gallon bucket. Later Lois sifted through the buckets we all had filled and removed the tiny cave pearls that were caught up in the cleaning. Then like a mother goose, she put them back in a nest in the cave.

On Sunday, our work groups were switched and Tom and I were put on the flowstone duty. The previous group's cleaning was spectacular and everyone could tell the difference. But by the time Tom and I got there on Sunday, the area to be cleaned would only hold a few restorers at a time. So, Tom joined Barb at the bottom of the flowstone and removed the slick mud while I stayed on the trail and interpreted our project to the visitors. In the afternoon, Tom and I exchanged jobs until quitting time. Since it was the Labor Day weekend, there were a lot of visitors and we did a lot of talking.

There was some dissatisfaction with the reasoning behind cleaning the flowstone in to Lower Cave when it was obvious that the flowstone would be muddied the next time there was a Lower Cave tour. Many suggested hanging the trail more to the side where there are more handholds thereby keeping visitors off of the newly cleaned flowstone. However, there is an electrical line there and that would have to be rerouted. It remains to be seen what happens but many fear a return to cleaning the flowstone is inevitable.

Little by little, the C.R.F. is making a difference in the overall restoration of Carlsbad Caverns. But with a million visitors a year circulating through the caverns, there will continue to be projects for volunteer cavers. just as soon as we finished up our cleaning on Sunday, Tom and I took a stroll over to Longfellow's Bathtub to look at the new bridge and in the short walk we managed to see pen lights, baby bottle tops, tissue paper, and coins lying off trail. At any rate, we cavers will come and work tediously for free in an effort to preserve this great cave we love so much.
