CAVE TRIPS:




RECENT ACTIVITY:

crats. You'll certainly hear soon from Evelyn Bradshaw, as a minimum. Please let me know if response not satisfactory.



6 March '84 Dear P.B.S.S. Editor:

As I have been a member of the T.S.A. (Texas Speleological Association) and it's activities for many years, I felt compelled to write expressing my views on the P.B.S.S. retaining it's T.S.A. affiliation status. I feel it is vitally important to keep the P.B.S.S. a functional branch organization of the T.S.A. and separate from the "Southwestern Region of the N.S.S." I am familiar with the P.B.S.S. caving areas and the likely problems the organization may find. In the past, communications between state grotto representatives and those of the West Texas area have been poor and infrequent at best. There are (have been) numerous reasons and contributing factors for this; however most of it has been due to the separation by distance alone. Things are changing fortunately, but its still slow as the Texas caving scene trends toward the West. Efforts are being made to fill in the gap of communications to further unite central and West Texas cavers and their organizations. I for one complained about this problem for years. The annual Texas "Old Timers Reunion" has done alot to help, but it has still been a long distance for West Texas cavers to attend. It has not been an easy, or by any means a successful task getting the bulk of caving people to meet or hold meetings in the West Texas area. What is important however is to let you know that these problems have been realized, and greater efforts in communications are underway. On May 18, 19, 20/84 the annual T.S.A. convention will be held on the Llano river near Kingsland, Texas. This is further westward than it has been in a long time. I urge the attendance of as many P.B.S.S. cavers as possible. This meeting would be very important for the grotto as there will be alot to offer. If some representatives can attend, I will make arrangements to set up and hold a meeting designed to discuss (with T.S.A. reps.) T.S.A. benefits and any problems etc. the P.B.S.S. may have. I have contacted T.S.A. V-P George Love to extend you a personal invitation and information on the convention as well as some info. on organization structure (which might be of possible use).

From this point in time, organized caving groups in West Texas will undoubtedly be making the greater contributions to Texas speleology, as there is such a vast amount of potential to work with. I can speak in behalf of T.S.A. in saying that we dearly want to see the work that the West Texas Cavers do (mapping etc.) go toward benifitting the T.S.S. (Texas Speleological Survey) of which we hope to better acquaint the P.B.S.S. with the people, projects, etc. The T.S.S. is there for all state T.S.A. grottos to use. On that note, I will close by saying "Stay T.S.A."!!! We really need your attendance at convention 84. Sure hope to see you there. RSVP please.
